The ANMF Aged Care Training Room CPD Solution is available as an annual subscription. The annual subscription is a tax deductible expense.

Please read these terms and conditions before proceeding with your subscription payment

1. The ACTR is accessible from most browsers. We highly recommend **Google Chrome** as it is free to download and requires minimal configuration to access the ANMF ACTR website.
2. Pop-ups will need to be allowed specifically for the ANMF ACTR website.
3. ACLS will:
 - a. Process your payment and provide you with a tax invoice and order confirmation within 2 working days
 - b. Create a 12 month subscription for the ANMF ACTR CPD Solution for your use from the date of payment
 - c. Send you (via email):
 - i. A login ID and password to access the ACTR, Annual Program, Catalogue and CPD tools
 - ii. Provide you with contact details and Help Desk services during business hours

4. Your subscription provides you with:

- a. Automatic enrolment in the learning activities as per the current annual learning plan

- c. Payment is 12 calendar months in advance. The annual subscription payment is due when you complete the online payment form
- d. Minimum subscription renewal period is 12 calendar months thereafter. You will be automatically sent a renewal notice when your next year's subscription is due. ***You are not obliged to re- subscribe***
- e. Refunds will only be given if you cancel within 14 days of paying your subscription.
